However, N.Y. State being a pro-labor state, has filed and received a court injunction to stop Judge Owen's judgment. Now it is up to us Brothers—Get the pens out of mothballs and write your legislators to put on the pressure to get this ruling reversed. Remember--Local No. 1 has been notorious for having very long strikes, and if we ever do decide to go out again, that extra \$11 could mean food on the table. Right now our Brothers in the International are fighting for their new contract and we are all pulling for them so their contract can be resolved.
